Mr. Grace said he did not recall agreeing to contact the owner.



Mr. Kavanaugh said the Town Council President is a representative of the real estate firm. Ms. Buehlman said she will contact Mrs. Hughes about the issue. The address of the property is 519 St. Catherine. There is a fence built over the ditch and that holds the trash, Mr. Keelor said.

Ms. Buehlman said the town crew is working on the Overlook Park.
